## 1. OBJET

Since I do not have a credit history of at least twelve months, and thus do not meet the eligibility criteria specified in *Communauto's* Contract, and since I am unable to find someone to act as my surety, **I the undersigned:**

request that Communauto consider the possibility of approving my membership application on the condition that I pay an additional refundable fee of \$500, to be added to the membership fee usually required by *Communauto* of its members. **hereinafter called the "Client"**

## 2. CONDITIONS

**2.1** After the minimum term of the Contract (one year), the Client may request a review of his credit report. If, at that time, the Client's credit report meets *Communauto's* eligibility criteria, the Client may obtain a refund of the aforementioned additional fee without having to cancel his membership. If the Client's credit report does not meet *Communauto's* eligibility criteria, he can nonetheless obtain a refund of said additional fee without having to cancel his membership, provided that he finds someone that meets *Communauto* eligibility criteria to act as his surety. Unless he avails himself of either of these two provisions, and provided that he is in good standing according to the Contract and the Rules & Regulations, the Client can continue to use the service as long as *Communauto* retains said additional fee in full.

**2.2** *Communauto* reserves the right to charge the administrative fee then in effect, as specified by the Rules & Regulations, for any review of the Client's credit report or for the approval of a new surety. This fee is applicable for each credit report verification.

**2.3** If a Client who has conformed to *Communauto's* eligibility criteria requests a refund of the additional fee he paid, said refund will be issued without delay subject to compensation between the parties for any amount owed by the Client in accordance with the Contract or the Rules & Regulations. In the event of Contract cancellation, if the additional fee paid by the Client and the membership fee are not sufficient to cover the Client's debt to *Communauto*, the latter reserves all its rights and recourses required to recover the full amount. This waiver application shall not be interpreted as having any effect on the conditions specified in the Contract regarding the refund of the membership fee. In the event that the French and English versions do not concur, the French version shall prevail.
